1. **Karaiyamai Rural Municipality** invites sealed bids or electronic bids from Nepalese eligible bidders for the construction of “**Nirmit Guru Yojana ka Adharma Sthaniya taha ko Sajhedaarima Bidhalaya ko Bhautik Nirman**” under National Competitive Bidding procedures. The estimated amount for the works is **Rs 7558221.85 [Exclusive VAT and PS]**.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Karaiyamai Rural Municipality, Karaiya, Bara, Madhesh Province, Nepal or may visit PPMO e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp).
3. A complete set of Bidding Documents may be purchased from the office **Karaiyamai Rural Municipality** by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of **3000** till **2083/02/20** during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's Web Site [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at **Karaiyamai Rural Municipality office** at 2083/02/20
5. Sealed or electronic bids must be submitted to the office Karaiyamai Rural Municipality, Bara, Madhesh Province, Nepal through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before (2026/06/03) 2083/02/20, 12:00. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at (2026/06/03) 2083/02/20, 13:00 at the office of **Karaiyamai Rural Municipality , Bara**. Bids must be valid for a period of **90 days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of **NRS 2,20,000** which shall be valid for 30 days beyond the validity period of the bid
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
