1. Karaiyamai Rural Municipality, Office of Municipal Executive , Karaiya Bara **has allocated** towards the cost of Construction of RCC Bridge along Belahi River and intends to apply part of the funds to cover eligible payments under the Contract for **KRM/NCB/W/16/078/079**. Bidding is open to all eligible as per Section V of bidding document...
2. **Karaiyamai Rural Municipality** invites sealed bids or electronic bids from eligible bidders for the construction of Construction of RCC Bridge along Belahi River under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
  - Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **enter NRs 70( seventy ) Million**
  - Minimum Work experience of similar size and nature: **At least Two project of Bridge Works within the last ten (10) years, each with a value of at least NRs 80(Eighty) Million**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bidders must submit their bid electronically upon payment of a non-refundable fee of **NRs. 10000.00** till **09-04-2022 12:00 noon** and download the bidding documents for e-submission from PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the office (revenue) account as specified below:

6. Pre-bid meeting shall be held at **Karaiyamai Rural Municipality, Office of Rural Municipal Executive** at **04-04-2022 01:00pm**.
7. Electronic bids must be submitted through PPMO's e-GP system [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12 noon** on **14-04-2022**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **2 pm** on **14-04-2022** at the office of **office of Rural Municipal Executive, Karaiyamai Rural Municipality, Bara**. Bids must be valid for a period of **120 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **13,50,000.00** which shall be valid for 30 days beyond the validity period of the bid. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
